INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

Padmavani Arts and Science College for Women, located on the Salem-Bangalore national highway (NH 47), boasts a sprawling campus spread across 10.61 acres. With a strong focus on providing quality higher education for women, the institution is well-equipped with modern facilities to support academic excellence.

The college features 96 classrooms, all equipped with ICT facilities and a Wi-Fi-enabled campus to facilitate interactive learning experiences. Among these, 37 classrooms are equipped with LCD projectors, enhancing multimedia presentations. The majority of classrooms, spanning 660 square feet each, are furnished with steel furniture and have a seating capacity of 64 students, ensuring a comfortable learning environment. Additionally, there are 7 smaller classrooms covering 330 square feet, accommodating 25 students each.

Laboratories play a crucial role in practical learning, and Padmavani Arts and Science College for Women boasts 18 well-equipped laboratories. These include 8 undergraduate laboratories, 6 postgraduate laboratories, 3 allied laboratories, and 1 language laboratory. The college continuously evaluates and upgrades its laboratory infrastructure to meet the evolving needs of its academic programs.

The college allocates a significant area of 21,638 square feet for a playground, underscoring its commitment to promoting outdoor sports and activities. Additionally, dedicated spaces include a sports room spanning 1,320 square feet and a store room covering 660 square feet, equipped to support various sporting events and activities.

For outdoor games, the college offers five court/field facilities, including expansive fields for football ($125m \times 85m$) and hockey ($91.4m \times 55m$), as well as courts for volleyball ($18m \times 9m$), kabaddi (1,620 square feet), and handball ($40m \times 20m$, 800 square feet). Furthermore, there are facilities for kho-kho ($24m \times 16m$).

Indoor games are also prioritized, with a dedicated area of 3,000 square feet for carrom, chess, table tennis, and shuttle badminton. Additionally, the college features a well-equipped gymnasium covering 850 square feet to promote physical fitness among students.

To foster cultural activities, an open auditorium located in the Mother Teresa block accommodates up to 1,000 individuals, boasting a full-size stage spanning 3,000 square feet. This space encourages students to showcase their talents and creativity, contributing to a vibrant campus culture.
